 - i. Treasury Report- everything up to date, only pending items are 3 invoices from fundraiser and ABC request (information for both below)
 1. As of 10/31 \$35,247, will be closer to \$30,000 after fundraiser invoices and ABC is paid
 - ii. ABC requests- only 1 pending at this time (Demi Harlan ~\$1500- art room amplifier, PTO has received more information for this request and vote will be sent out soon on whether to approve)
 1. Depending on whether spring music show is possible for DVE, may have request from Mrs. Eckhoff for new risers (\$640) and spring musical fund (\$500)
